The doors to check-in will not open until 2:45 pm. Please do not show up before then. Have your printed registration form and a check for any remaining balances with you at check-in if you have not pre-registered.

Any person(s) arriving at camp prior to official registration time will be personally liable for any accidents, damages, or injuries. Early arrivals make it impossible for the camp director to have a pre-camp inspection of the facilities. No early registration or camper drop-off will be accepted before 3:00 pm.

## EARLY REGISTRATION FEES

Early registration ends on June 30, 2021. **To qualify, a completed registration form and a \$50 non-refundable fee per camper must be received by the camp registrar in order to guarantee your camper's spot.**

All remaining balances will be due by/at camp check-in July 18, 2020.

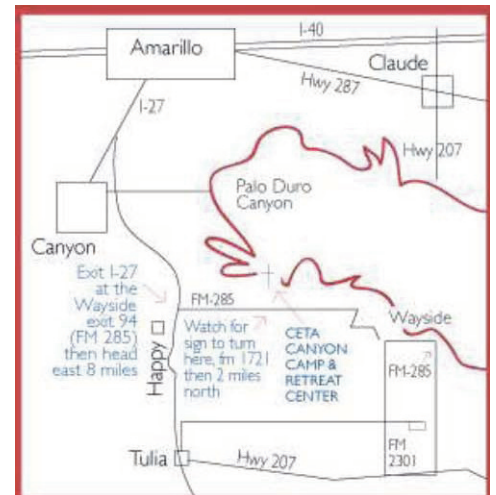
## THINGS TO PACK

**PARENTS: Please label all campers' articles and clothing!! Camp/Camp Staff will not be responsible for items left behind. Below are other suggested items to pack:**

Bible, pencil & notepad, swimsuit & towel, pillow, towels/washcloths, bed sheets, blanket or sleeping bag, toiletries, jacket/sweater, 1 set of dress clothes, snack money, snacks (optional), camera (optional), sport clothes/tennis shoes, flashlight, sunscreen, bug spray, jeans/sweat pants (for hiking), and alarm clock if needed. **If you choose not to submit your cell phone to camp staff for holding, it can be confiscated by any camp staff at any time if they feel you are abusing the privilege of a cell phone or are a distraction to others.**

## DIRECTIONS TO CAMP

Take I-27 North to Amarillo or South from Amarillo. Take the Wayside exit which is HWY 285 from I-27. You will go EAST on HWY 285 approx. 8 miles, you will see signs that say church camps. You will turn NORTH (left) and go about 2 miles. At the bottom of the canyon, turn LEFT at the Christian Camp Sign. Please drive in slowly for other campers may be unloading.

## CELL PHONE POLICY

Each camper has the option to let the PSPLCA camp staff safely hold their cell phone in a locked area from Sunday, July 18, through Friday, July 23, 2021. The cell phone will be returned to the camper at camp during designated times set by camp director, no later than July 23, 2021.

PSPLCA will not be held liable for any lost, damaged or stolen cell phones or other electronic communication devices that are not officially registered and placed in a locked area from July 18-23, 2021. Cell phones that are found unregistered by camp staff during the week of camp can be confiscated and placed in a locked area. If for any reason the camper needs to use a cell phone during the week of camp, he/she can request the assistance of a camp counselor or director.

# PANHANDLE SOUTH PLAINS LUTHERAN CAMP ASSOCIATION CAMPER COVENANT CONDUCT FORM

This camp covenant is our commitment to each other for how we will act, interact, and react during the entire camp experience in a God pleasing manner.

## **1. We agree to honor one another as members of God's family during the church camp experience by treating each other in the following Christian manner:**

- Show concern for others' physical and emotional well-being.
- Use words and actions that "build people up."
- By using "welcoming traditions" that would glorify God in thought, word, and deed according to Luther's explanation of the fifth commandment stating that we should fear and love God so that we do not hurt or harm our neighbor in his body, but help and support him in every physical (and emotional) need
- Have a positive attitude and be flexible when things go wrong or schedules change.
- Understand that leaders will sometimes make decisions that we don't like but we will be supportive anyway. (When in doubt see point #2)

## **2. We agree to care for each other at camp by helping each other in these ways:**

- Offering to carry luggage, open doors, or assist with any job (sometimes even before being asked).
- Be on time for meetings, so we don't hold everyone up.
- Be considerate of shared space such as dorms and sleep time.
- Be respectful of any other campers' property, camp property or anything else that is thy neighbor's.

## **3. We agree that we are called to be responsible to one another, the families and churches we represent, therefore we will deal with these behavior issues in the following ways:**

- With members of the opposite sex, we will show respect and follow Biblical guidelines for Christian conduct always being concerned for the other person's reputation, feelings, and well-being. (Keep it clean! Appropriate public display of affection only.)
- Opposite genders will not be in dorms without the direct supervision of a staff member.
- When we are angry, hassled, or upset we will talk to the person(s) involved (Matthew 18) or seek the help of an adult in resolving a problem.
- We will not purposely invade another campers' personal space.
- We will refrain from smoking or the use of any tobacco product.
- We will not engage in substance abuse of any kind including alcohol.
- We will use common sense and Christian care when an issue is not covered by this covenant.
- We will refrain from using music that is offensive in any way in any format including personal headphones or music publicly heard.
- In consideration for our own safety and in respect of our interactions with others, we willingly agree to refrain from using cell phones while at camp without the direct permission from the Camp Director.

## **4. We agree to be appropriately dressed for all events:**

- We will not, at any time wear shirts that reveal the midriff area.
- We will not, at any time wear shorts or pants that reveal the backside or underwear.
- We will not wear shirts that show inappropriate words.
- Parents are expected to encourage their youth towards modest swimsuits.
- Girls: Be prepared to wear a t-shirt over swimming apparel if your midriff shows!

## **5. In this covenant, we willingly agree to abide by these expectations**

- Full participation in all scheduled camp events.
- Full cooperation with any and all camp staff.
- We will fully understand and support camp staff in times of unforeseen schedule changes.

## **6. In addition, we expect our camp staff members to:**

- Follow the same rules we have to follow.
- Show patience and try to get the “whole story” before reacting.
- Show a lighthearted, loving, fun side to themselves.
- Consult campers in making decisions whenever appropriate with regard to activities.
- Follow this covenant fairly in dealing with any & all problems.

## **7. When someone refuses to follow this covenant, we will handle the problem with the following consequences.**

- You may be asked to consult privately with the Camp staffers or other youth involved in the problem.
- You may be asked to spend part or all of the day under the direct supervision of an adult leader with no choices in activities.
- For serious infractions of this covenant there will be NO TOLERANCE allowed. These infractions include alcoholic beverages consumption or tobacco use of any kind, fornication, hazing, and/or bullying, or anything punishable as a misdemeanor or felony, and/or repeated lesser violations of this covenant. This NO TOLERANCE POLICY means that parents will be notified immediately regardless of the time of day or night. Parents will then have up to 4 hours to secure first available transportation home at parents' expense or inconvenience and camper will depart camp within a reasonable amount of time as agreed upon by the Camp Director.
- Camper(s) breaking any part of this Covenant, or acting in any way that the Camp Director feels to be inappropriate, may be asked to leave the camp without receiving a camp refund.
